**Albion Local Option Sales and Use Tax Renewal**

"Shall the City of Albion, Nebraska renew and continue to impose a sales and use tax of one-half of one percent (0.5%) upon the same transactions within the City of Albion, Nebraska on which the State of Nebraska is authorized to impose a tax pursuant to the Nebraska Revenue Act of 1967 as amended, with thirty percent (30%) of the tax proceeds to be used for Fire Department Building, Equipment, and Maintenance requirements; ten percent (10%) of the tax proceeds to be used for Police Department

Building, Equipment, and Maintenance requirements; five percent (5%) of the tax proceeds to be used for City Hall Building and Maintenance requirements; five percent (5%) of the tax proceeds to be used for Library Building and Maintenance requirements; and, fifty percent (50%) of the tax proceeds to be used for Swimming Pool Bond Property Tax Relief for a period of ten (10) years?"
