VOTER REGISTRATION INFORMATION

DEADLINES:

- ***In Person Office Registration*** – Second Friday preceding an election (32-302)
 - Primary Election: May 2, 2016 at 6:00 P.M.
 - General Election: October 28, 2016 at 6:00 P.M.
- ***Registration Delivered*** – Last day a person other than the voter can deliver a registration form (32-321, 32-325)
 - Primary Election: April 22, 2016
 - General Election: October 21, 2016
- ***Mail-In Registration Form*** – Must be postmarked on or before the third Friday before the election (32-321)
 - Primary Election: April 22, 2016
 - General Election: October 21, 2016
- ***Registration completed Online, at County Treasurer/Driver's License Exam Office***
 - Primary Election: April 22, 2016
 - General Election: October 21, 2016
- ***Mail-In Registration Form with Illegible Postmark*** – Registration is accepted if received in the County Clerk's office no later than the second Tuesday before an election (32-321)
 - Primary Election: April 26, 2016
 - General Election: October 25, 2016

EARLY VOTING INFORMATION

DEADLINES:

- ***First day to accept early voting ballot request for General Election*** – 120 days prior to an election (32-941)
 - Primary Election: January 10, 2016
 - General Election: July 11, 2016
- ***First day for in person Early Voting at the Election Office*** – 30 days before election (32-942)
 - Primary Election: April 11, 2016
 - General Election: October 10, 2016
- ***To apply for a ballot by mail*** – Wednesday before the election (32-941)
 - Primary Election: May 4, 2016 at 4:00 P.M.
 - General Election: November 2, 2016 at 4:00 P.M.
- ***To apply for a ballot by mail if person is not a registered voter*** – Third Friday preceding an election (32-945)
 - Primary Election: April 22, 2016
 - General Election: October 21, 2016
- ***To vote in person at the Clerk's office*** – Monday before the election (32-942)
 - Primary Election: May 9, 2016
 - General Election: November 7, 2016
- ***For agent to pick up ballot*** – Election day (32-943)
 - Primary Election: May 10, 2016 at 7 P.M.
 - General Election: November 8, 2016 at 7 P.M.
- ***For agent to return voted ballot*** – Election day (32-950)
 - Primary Election: May 10, 2016 at 8:00 P.M.
 - General Election: November 8, 2016 at 8:00 P.M.
- ***For voted ballot to be returned by mail*** – Election day (32-950)
 - Primary Election: May 10, 2016 at 8:00 P.M.
 - General Election: November 8, 2016 at 8:00 P.M.

APPLICATION FOR EARLY VOTING:

- Application must be in writing and shall indicate voter's residence address, the address to which the ballot should be mailed, if different, telephone number and voting precinct, if known (32-941).
- Application must be signed by the voter or voter's agent (32-941).
- Agent can apply for a ballot and/or pick up a ballot for another person (32-943).
- No person shall act as agent for more than two voters for any election (32-943).
