PUBLIC HEARING PROCEEDINGS

2018 ONE AND SIX YEAR ROAD IMPROVEMENT PROGRAM BOONE COUNTY, NEBRASKA

Ken Luettel, Boone County Board of Commissioners Chairman, called for a motion to open a public hearing on Monday, March 19, 2018 at 10:00 A.M. in the County Commissioners Meeting Room, Boone County Courthouse in Albion, Nebraska. Motion made by Commissioner Maricle, second by Commissioner Rasmussen to open said public hearing. Commissioners present for said public hearing were Hilary K. Maricle, Alan Rasmussen and Ken Luettel. Stacey L. Robinson, County Highway Superintendent, was present to answer the 2018 Road Improvement Program questions. Notice of the hearing was given in advance by publication and the convened hearing was open to the public.

The public hearing is for the purpose of hearing testimony in favor of, or opposition to, and to answer questions in relation to the proposed 2018 One and Six Year Road Improvement Program for Boone County, Nebraska. The hearing is to remain open for one hour.

Stacey L. Robinson, Boone County Highway Superintendent, presented the 2018 One and Six Year Road Improvement Program for County of Boone, Nebraska on February 20, 2018. Due to the February 20, 2018 notice of public hearing not being published in the local newspapers, Robinson re-presented the 2018 One and Six Year Road Improvement Program for County of Boone, Nebraska at the 10:00 A.M. public hearing on Monday, March 19, 2018 as advertised and posted.

The one-year road improvement plan consists of eight projects and the six-year plan consists of six projects. Robinson prepared a map to use as a visual aid showing the location of the proposed projects. The Board received no opposition at the hearing.

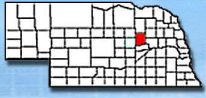
Robinson acknowledged that Project No. C-6(391) and C-6(393) are bridge projects that need to be completed as soon as possible. Robinson acknowledged Project No. C-6(394), road re-surfacing of four miles of asphalt from 210th Avenue west to 170th Avenue. Robinson and the Board discussed each of the projects. Ed Braun inquired about the condition of a culvert on 190th Avenue. Robinson said she plans to check out the culvert concern. In addition, the one-year projects include three bridge replacements and three micro-surfacing of asphalt roads. The six-year projects include bridge replacements and road reconstruction. The federal and state regulations regarding bridge and road construction project funding is pushing more of the burden onto the county.

Attached hereto as part of the proceedings is a copy of the 2018 proposed projects one-year plan and six-year plan as presented by Boone County Highway Superintendent, Stacey L. Robinson.

Motion made by Luettel, second by Maricle to close said hearing at 11:05 A.M. Roll call vote: Yeas: Luettel, Maricle and Rasmussen. Nays: None. Motion carried.
