VOTER REGISTRATION INFORMATION

DEADLINES:

- **In Person Office Registration** – Ending at 6 P.M. on the 2nd Friday preceding an election. (§32-302)
 - Primary Election: May 4, 2018 at 6:00 P.M.
 - General Election: October 26, 2018 at 6:00 P.M.
- **Registration Delivered** – 3rd Friday preceding an election. (§32-321, §32-325)
 - Primary Election: April 30, 2018
 - General Election: October 19, 2018
- **Mail-In Registration Form** – 3rd Friday preceding an election. (§32-941, §32-945)
 - Primary Election: April 30, 2018
 - General Election: October 19, 2018
- **Registration completed Online, at DMV** – 3rd Friday preceding election. (§32-304, §32-308)
 - Primary Election: April 30, 2018
 - General Election: October 19, 2018
- **Mail-In Registration Form with Illegible Postmark** – 2nd Tuesday before the next election. (§32-321)
 - Primary Election: May 1, 2018
 - General Election: October 23, 2018

EARLY VOTING INFORMATION

DEADLINES:

- **First day to accept early voting ballot request for Primary/General Election** – 120 days prior to an election (§32-941)
 - Primary Election: January 14, 2018
 - General Election: July 8, 2018
- **First day for in person Early Voting at the Election Office** – Not more than 30 days prior to the day of election (§32-942)
 - Primary Election: April 16, 2018
 - General Election: October 9, 2018
- **To apply for a ballot by mail** – Close of business on the 2nd Friday preceding the election. (§32-941)
 - Primary Election: May 4, 2018 at 6:00 P.M.
 - General Election: October 26, 2018 at 6:00 P.M.
- **To apply for a ballot by mail if person is not a registered voter** – 3rd Friday preceding an election (§32-941, §32-945)
 - Primary Election: April 30, 2018
 - General Election: October 19, 2018
- **To vote in person at the Clerk's office** – Monday before the election (§32-942)
 - Primary Election: May 14, 2018
 - General Election: November 5, 2018
- **For agent to pick up ballot** – 1 hour prior to the closing of the polls on Election Day. (§32-943)
 - Primary Election: May 15, 2018 at 7 P.M.
 - General Election: November 6, 2018 at 7 P.M.
- **For agent to return voted ballot** – Election day (§32-950)
 - Primary Election: May 15, 2018 at 8:00 P.M.
 - General Election: November 6, 2018 at 8:00 P.M.
- **For voted ballot to be returned by mail** – Election day (§32-950)
 - Primary Election: May 15, 2018 at 8:00 P.M.
 - General Election: November 6, 2018 at 8:00 P.M.

APPLICATION FOR EARLY VOTING:

- Application must be in writing and shall indicate voter's residence address, the address to which the ballot should be mailed, if different, telephone number and voting precinct, if known (§32-941).
- Application must be signed by the voter or voter's agent (§32-941).
- Agent can apply for a ballot and/or pick up a ballot for another person (§32-943).
- No person shall act as agent for more than two voters for any election (§32-943).
